The following Notification will be published in the Extra ordinary issue of Andhra Pradesh Gazette, dated:19.07.2019.

**NOTIFICATION**

In exercise of the powers conferred by section 115 (2) of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Andhra Pradesh Act No.5 of 2016), Government of Andhra Pradesh hereby authorise the Director of Town & Country Planning to issue Technical Approval for all Development Permissions as per the prevailing rules until further orders in the newly constituted Urban Development Authorities viz., 1)Eluru Urban Development Authority (ELUDA), 2) Annamayya Urban Development Authority (ANUDA) 3) Ongole Urban Development Authority (ONUDA) 4) Chittoor Urban Development Authority (CHUDA) 5) Palamaneru Kuppam Madanapalle Urban Development Authority (PKM-UDA) 6) Bobbili Urban Development Authority (BUDA) and 7) Srikakulam Urban Development Authority (SUDA).

2. The Vice-Chairpersons of the Urban Development Authorities, Commissioners of Urban Local Bodies and Panchayath Secretaries of Gram Panchayats concerned shall take necessary action, accordingly.
3. The Director of Town Country Planning, AP., Guntur shall follow the prevailing delegation of powers in the Department for effective compliance of Ease of Doing Business (EoDB) parameters.
