With reference to the above, it is to submit that, the MoEF&CC, Gol, New Delhi issued the Coastal Regulation Zone Notification No. S.O. 19(E), dated the 6th January, 2011. As per the notification, Coastal Zone Management Plans (CZMPs)-2011 were approved by MoEF&CC, Gol, New Delhi. They were displayed in the website of APCZMA. The APCZMA is appraising the CRZ applications received, as per above CZMPs.

In supersession of the above Notification, the Ministry of Environment and Forests and Climate Change (MoEF & CC) published Coastal Regulation Zone Notification 2019, dated 18th January 2019. As per CRZ Notification 2019 notified by MoEF&CC, Gol preparation of Coastal

Zone Managements Plans (CZMPs) for the State of Andhra Pradesh is mandatory for land use, land cover and development.

The EFS&T Dept., Govt. of A.P. has entrusted the work of preparation of CZMPs to M/s. National Centre for Sustainable Coastal Management (NCSCM), as per CRZ Notification 2019. Accordingly, draft CZMPs & Land Use Land Cover (LULC) maps were prepared by NCSCM, MoEF&CC, Gol, Chennai and submitted to APCZMA.

Now, Public Hearings are to be conducted in the Coastal Districts of Andhra Pradesh as per the procedure in vogue, duly displaying the draft CZMPs & LULC maps in the public domain and in the Coastal Mandals/ Villages/ Local Bodies.

The draft Coastal Zone Management Plans of Prakasam district have been prepared on 1: 25000 scale as per the provision given in the CRZ Notification 2019 and guidelines issued by MOEF&CC dated 26th June 2019. The draft Plan has been prepared indicating CRZ I (Ecological Sensitive Areas), CRZ II (Developed Area), CRZ - III A (rural areas with population density more than 2161 per sq. km) and CRZ - III B (rural areas with population density less than 2161 per sq. km), CRZ IV (Water Area), Cadastral information, etc.,

The District Collector, Prakasam has approved the date, time and venue of Public Hearing as follows:

Time : 11.00 AM
Venue : Near Brundavan Resorts, Kothapatnam beach, Prakasam District.

As per the EIA notification, on receipt of the Executive Summary reports & CZMP maps, the above authorities shall arrange to widely publicize within the respective jurisdictions requesting the interested persons to send their comments to the concerned regulatory authorities and also, they shall make available the reports for inspection electronically or otherwise to the public during normal office hours till the Public Hearing is over.

In view of the above, CZMP Maps and executive summary in Telugu & English are herewith enclosed. It is requested to make it available to public / concerned persons during normal office hours till the public hearing is over. Further, I request you to kindly forward suggestions/objections, if any received in your Office on the above said draft CZMP immediately to this office for further necessary action.
